Attenti's a.Check mobile app is a customizable check-in app using biometric recognition to ensure reliable participant monitoring. a.Check provides officers the means to efficiently communicate with and supervise participants from the office and in the field.



The officer selects the required service(s) in Attenti's EM Manager software, enters the check-in schedule, and has the participant download and install a.Check from the App Store or Google Play.

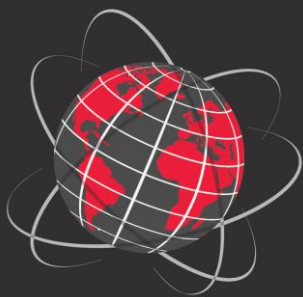

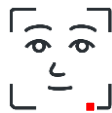
