The North Carolina Sheriffs' Association (NCSA) has made the decision to execute Section 1.5 *Term of Contract* and extend all current contracts for one additional year. Bid 22-03-1027 will remain in effect until November 6, 2022.

On November 7, 2022, all current contracts will rollover and the NCSA will publish all rollover contracts as Bid 22-03-1027R. The rollover contract will be effective November 7, 2022, through November 6, 2023. All updated Authorized Dealer lists and Price Sheets will go into effect on November 7, 2022.
