2021/2022 Heavy Equipment Bid 22-06-0426

This letter serves as the Association's official solicitation to dealers and manufacturers for the North Carolina Sheriffs' Association's 2021-2022 Heavy Equipment Procurement Program. The North Carolina Sheriffs' Association (NCSA) is very excited to begin working on the fifth year of our Heavy Equipment Procurement Program. Enclosed you will find the NCSA's Heavy Equipment Procurement Program's official 2021-2022 bid calendar.

As our Heavy Equipment Program continues to grow and expand across North Carolina <u>and in other states</u>, the NCSA is excited to announce this year we will be implementing our new online bid system, VendorLink. As a result of this change and the importance of a smooth transition, the Association will <u>not</u> be implementing the rollover clause for the 2021-2022 contract year. All equipment will fall under Bid 22-06-0426 when contracts are awarded on May 18, 2021.

All bidding will now be completed through VendorLink and all dealers/manufacturers who wish to participate must register with VendorLink to have access to submit a bid. Registration will be open January 15, 2021 through March 25, 2021. We encourage you to complete your registration as soon as possible. If you already have an account with VendorLink you do not need to create a new account. No bids or required documents will be accepted outside of VendorLink, and the Association will not accept any hard bid submissions for Bid 22-06-0426.

All dealers/manufacturers will be responsible for uploading build sheets (previously referred to as specifications), option sheets (<u>must</u> include list of models available for upgrades/downgrades), and all required bid documents. The NCSA has extended the length of time you will have to submit a bid to allow all bidders



to successfully complete these requirements by the date outlined on the enclosed calendar.

The list of equipment currently offered through our program has been consolidated and uploaded into VendorLink. Please take a moment to review by logging into VendorLink and clicking on the Quote/Bid Items. The NCSA looks to our dealer and manufacturer partners for recommendations on which new models to add to our program as well as any changes that are effective with the new model year on existing equipment. As the Association works to prepare the first draft bid package, if any current contractors are aware of equipment that will not be available for the 2021-2022 contract year please notify Kaylyn by **January 29, 2021**.

Another change you will see this year is for certain groups (previously referred to as lot categories), we will be implementing a Catalog Discount. This option <u>will not</u> be eligible across all groups. If you do not see a group (previously lot category) that is applicable to your product offering(s), we will gladly add a new group. We encourage all bidders to pick the most popular base models you wish to include and have all other applicable upgrade/downgrades listed on the option sheet that will be uploaded with your bid.

We look forward to growing and providing the benefits of our cooperative bid program to even more county and city agencies across the Southeast. Additional information on our Heavy Equipment Program can be accessed at http://ncsheriffs.org/services/heavy-equipmentprocurement-program. Once you are on the website you will find information on the existing open bids, important documents such as the program's Terms and Conditions, and other bid support documentation. All important documents relating to the 2021-2022 bid period will also be available on VendorLink.
