As our Vehicle Procurement Program continues to grow, the NCSA is excited to announce our new online bid system, VendorLink. As a result of this change, the current nature of the automotive industry, and the importance of a smooth transition, the Association will <u>not</u> be implementing the rollover clause for the 2021-2022 contract year. All current contracts will remain in effect until October 1, 2021 with new contracts being awarded and going into effect on October 2, 2021.

June 11, 2021

All bidding will now be completed through VendorLink and all dealers who wish to participate must register with VendorLink to have access to submit a bid. Registration will be open June 11, 2021 through August 5, 2021. We encourage you to complete your registration as soon as possible. If you already have an account with VendorLink you do not need to create a new account. No bids or required documents will be accepted outside of VendorLink, and the Association will not accept any hard copy bid submissions for Bid 22-08-0913.

All dealers will now be responsible for uploading build sheets (previously referred to as specifications) and option sheets into VendorLink as part of the bid submission. This new requirement eliminates any errors of inaccuracy when building a vehicle specification and will save dealers time by not having to price each individual option per vehicle model. However, the option sheet uploaded into VendorLink will need to list the pricing for models outlined as an upgrade or downgrade to the base model and the most popular options available. All dealers and manufacturer representatives are strongly encouraged to attend the Pre-Bid Conference. Your attendance will be considered along with your overall bid package. During this year's Pre-Bid meeting, we will provide important VendorLink training.

Attached you will find the official calendar for the 2021-2022 contract year which outlines all Pre-Bid Conferences and other important deadlines.
